Process and Rationale: Third-Party Standard

Chronicle Advisers, Inc. chose B Lab's *B Impact Assessment*, a free, comprehensive, and transparent tool for assessing overall corporate social and environment performance, as its third-party standard. Chronicle Advisers, Inc. achieved a third-party audited score of 83.6.

Chronicle Advisers, Inc. 2024 Public Benefit Activities and Impact

Chronicle Advisers, Inc. pursued general public benefit in fiscal year 2024, as follows.

Governance

- Chronicle Advisers, Inc. maintained its New York State Public Benefit Corporation status as a precursor to B Corp certification.
- Chronicle Advisers, Inc. completed the B Impact Assessment with a final score of 83.6. Ultimately, Chronicle Advisers, Inc. opted not to finalize B Corp certification in 2024 in favor of pursuing certification under the new B Lab standards, expected in 2026.

Community Impact

Chronicle Advisers, Inc. fulfilled its mission to educate and advise businesses on environmental, social, and governance issues to minimize negative impact on the environment, drive sustainable economic development, and support the well-being of their employees, clients, and community through various pro bono activities, including:

- Worked with a number of companies across a range of sectors to seek government funding to support their projects and initiatives. This focused on developing narratives that best describe their projects and align key elements with government policy priorities.
- Guest lecturer on social entrepreneurship at the Quinlan School of Business at Loyola University
- Get-Out-the-Vote initiative volunteerism and postcard-writing
- Participated in lobbying efforts for climate justice legislation in partnership with New York Businesses for Climate Justice and New York Renews.
- Maintained membership with 1% of the Planet, donating at least 1% of total revenues to climate change projects.
- Continued participation on the Government Relations Committee at CenterState CEO, a Central New York economic development agency.
- Contributed to content, standards, practices, and assessment related to business sustainability at B Lab and the Global Reporting Initiative.
